Physiotherapy is essential in immediate post-breast cancer surgery rehabilitation.

Prevents and minimizes complications and promotes adequate functional recovery and improved quality of life.

TAKE CARE OF YOURSELF AND THOSE YOU LOVE!

The APAMCM - Associação Portuguesa de Apoio à Mulher com Cancro da Mama, was created on april, 6th, 1999 by an interdisciplinary group of volunteer health professionals linked to the issue of breast cancer.

In 2009 it became an IPSS – Instituição Particular de Solidariedade Social com Fins de Saúde, and is recognized as a Collective Person of public utility.

It is a non-profit organization and has been registered with the Health Regulatory Authority (ERS) as a healthcare provider since 2011

Located in Lisbon, it seeks to improve coordination with healthcare in accordance with the guidelines of the DGS National Program for Oncological Diseases.

Is mission focuses on providing preventive medicine and rehabilitation care to users with breast cancer disease.

# CENTER SPECIALIZED IN ONCOLOGICAL PHYSIOTHERAPY (CEFO)

In october 2006, CEFO was created with the aim of providing healthcare within the scope of oncological rehabilitation and, in 2007, it was recognized with the Good Health Practices Award "Service provided – Accessibility & Service".

**PROMOTES free physiotherapy treatments** for users in general **post-breast cancer surgery status**, and more specifically in **Lympho-Therapy**.



It uses a set of techniques and procedures in physiotherapeutic rehabilitation in the **post operative period of breast surgery and breast reconstruction**, such as: teaching exercises to gain range of motion and joint quality; massage to alleviate scarring and respiratory physiotherapy.

The **Lymphedema** is the most frequently complication during breast cancer treatment.

Being a chronic pathology, it can increase in volume and tends to organize itself.

- Manual lymphatic drainage
- Pressotherapy
- Multilawyer bands
- Teaching self-mobilization and self-positioning
- · Prevention and treatment of lymphedema

To schedule physiotherapy treatments, you must bring a prescription from your Surgeon, Oncologist, Physiatrist, Orthopedist or General Doctor.
